***Yard Debris** means any and all accumulations of grass clippings, grass, leaves, small trees, small shrubs, tree branches not exceeding four (4") inches in diameter and four (4') feet long, vines and other similar items generated by the maintenance of lawns, shrubs, gardens and trees from residential properties. All loose materials (leaves, mulch, twigs, etc.) are to be bagged in paper bags. Yard debris services are not provided for vacant lots. SIPOA will not pick up any yard debris placed in front of vacant lots. **Debris generated by contracted persons is not included for pickup under this program and must be removed from Seabrook Island by the contractor doing the work.**
